### First Board of Health Member Training Certification September 25th

The first in the nation certification program for members of local Boards of Health will be offered September 25, 2010, at the Middlesex County Fire Academy in Sayreville. This voluntary program is designed to develop the knowledge and skills necessary to members of Boards of Health in performance of their duties under New Jersey Public Health Practice Standards. Successful completion of this program will also confer certification in Incident Command System 100 and National Incident Management System 700 and will entitle members to use the initials CBHM (Certified Board of Health Member), after their names.

We urge you to extend an invitation to your Health Officer to join you in this training. Participants will receive training material, including the newly published *Board of Health Orientation Manual, A Guide to Roles and Responsibilities*. Those who wish will receive 6.0 CEU's from the New Jersey Department of Health and Senior Services.

Please register as soon as possible. The program schedule and registration form are included in this newsletter.

# Public Health Nursing

*The Key to a Healthy Community*

Public health nursing is the practice of promoting and protecting the health of populations using knowledge from nursing, social, and public health sciences (American Public Health Association, Public Health Nursing Section, 1996). The practice is population-focused with goals of promoting health and preventing disease and disability for all people through the creation of conditions in which people can be healthy.

Practicing in a variety of public and private organizations, all public health nurses focus on one or more populations. Population-based public health nursing practice focuses on entire populations that possess similar health concerns or characteristics. This includes everyone in a population who is actually or potentially affected by a health concern or shares a specific characteristic. Population-based public health nursing interventions are not limited to those who seek services, are poor or otherwise vulnerable. Public health nursing services and programs may be directed toward entire populations within a community and the systems that affect the health of those populations. The public health nurse partner's with communities and populations to reduce health risks and to promote, maintain, and restore health, advocating for system level changes to improve health.

Public health nurses are proactive with respect to social and health-care trends, changing concerns, and policy and legislative activities. They function as advocates for the populations they serve. Such advocacy for public health and social policies promotes a healthy environment, creates conditions that improve and enhance the health of populations, and is a key of public health nursing roles.

*ANA Public Health Nursing: Scope and Standards of Practice*

Public Health nurses are part of the foundation of the health department. They are advocates for health promotion and disease prevention. Public Health Nurses run child health conferences, cancer screenings, flu and other vaccination clinics to name a few. They investigate communicable diseases from mumps, to pertussis to salmonella. Sometimes one nurse provides all these functions for one local health department. The goal of public health nursing is to improve the health and well-being of all individuals, families, communities, and populations through significant and visible contributions. Public health nurses do this through core functions of assessment, assurance,

and policy development. The core functions are applied in a systematic and comprehensive manner.

As the economic climate continues to change, Boards of Health are finding it more difficult to hire experienced, appropriately educated nurses to fill the public health nurse positions. Public health nurses often work independently or with little staff. These positions require professionals with varied experience and increased confidence. Budgetary restraints make it very difficult for Boards of Health to offer competitive salaries to lure the best in the community for the position.

"Local health departments play an essential role in our nation's public health system because they protect the well-being of the American people. Each day, public health employee's work in often unseen ways to help keep each community safe and healthy," said Andrews. "To help ensure the safety of our nation's communities and improve the health and well-being of our citizens, local health departments need more workers engaged in public health and prevention—not fewer." "*The mounting cuts to local public health departments are the beginnings of a national tragedy,*" said Georges Benjamin, MD, Executive Director of the American Public Health Association. "Without robust, sustained investment in our public health infrastructure, the capacity and ability of this country to protect the public and prevent diseases is being severely eroded."

**Catastrophe for Public Health in the Making;** Local Health Department Job Losses Threaten the Health of All Americans, Washington, D.C. (July 1, 2010)

In the 21st century, the health care system will need prevention, health promotion and education, chronic care management, care coordination, someone who is knowledgeable about community resources and services. In addition; communicable disease follow-up and advocacy for health and the well being of the community- all roles of public health nurses. Prevention is always less expensive than treatment. Public Health Nurses will hopefully have a large part in Health Care Reform, since their practice is based on the health of the community.

## **President's Message**

As promised, 2010 has been an exciting year for public health and for your New Jersey Association of Local Boards of Health. Officers and Executive Board members have worked hard to provide ideas and direction, which assist us in accomplishing our two major goals of this year.

Our first goal is to provide greater services, including training opportunities, advisory legal assistance and communications for our member Boards. To that end, we have established the first ever Board of Health Member Certification Program and have scheduled our October 23 annual conference and training session.

Our second major goal is to become ever more effective advocates for public health in the State of New Jersey. To further that goal, we have established working relationships with State Legislators and are particularly grateful for the support offered to both our Association and public health by Senator Loretta Weinberg. We have been honored by close working relationships with the NJ Society of Public Health Educators, the New Jersey Association of Public Health Nurse Administrators, the New Jersey Environmental Health Association and the New Jersey Department of Health and Senior Services.

It is my belief and that of your Executive Board that NJLBHA should work in partnership with the above organizations and with all other parties interested in public health for the betterment of our citizens.

### **NALBOH Update**

The Executive Board of NJLBHA has become increasingly disturbed at the continuing and inaccurate attacks on NJLBHA by NALBOH as well as NALBOH's refusal to make reforms. We considered developing an item-by-item response to some of their propaganda and lies, but the Executive Board felt that improving public health in New Jersey is a better use of our resources than reforming NALBOH. Our attorney has recommended that NJLBHA withdraw from affiliate membership in NALBOH, so as to avoid being tainted by their actions. The Executive Board is taking this recommendation under advisement. Also with the advice and approval of our attorney, we have written letters, with documentation, to all the members of the New Jersey Congressional delegation, asking for an investigation into NALBOH activities and their use and distribution of funds. Once again, we cannot recommend that any local Board of Health join NALBOH until NALBOH undertakes reform. Except for perhaps announcing our withdrawal from NALBOH, It is our hope that this is the last time we will take up valuable space in our newsletter to give you updates regarding that organization.

## **NJLBHA Withdraws from NALBOH**

*At our August 25<sup>th</sup> board meeting, the following resolution was approved unanimously by your board. It was felt that all our efforts should go to the benefit of the citizens of NJ and based on our attorney's advice we are withdrawing from NALBOH in order to maintain the integrity of your Association and avoid being tainted by their activities. The last part of the following resolution urges all boards of health in the state of New Jersey to do the same.*

### **Resolution by the Executive Board of New Jersey Local Boards of Health**

Whereas, the National Association of Local Boards of Health (hereinafter known as NALBOH) has consistently violated fundamental due process in the removal of elected NALBOH Directors from the State of New Jersey; and

Whereas, NALBOH refuses to recognize the duly elected officers of the New Jersey Local Boards of Health Association (hereinafter known as NJLBHA) and refuses to communicate with said officers; and

Whereas, NALBOH has violated the terms and conditions of the agreement between NALBOH and NJLBHA as a State Institutional Member by refusing representatives appointed by the President of NJLBHA participation in any of its State Association of Local Boards of Health meetings; and

Whereas, NALBOH has failed to answer requests for data relating to NALBOH's financial accountability; and

Whereas, NJLBHA and the local Boards of Health of the State of New Jersey have met their obligations in paying dues to NALBOH and yet received no offers of assistance and support for NJLBHA programs; and

Whereas, NJLBHA strongly disagrees with attempts by the NALBOH Board of Directors to disenfranchise voters in the election of NALBOH Directors; and

Whereas, NJLBHA has reached out on numerous occasions to NALBOH Board of Directors to resolve issues of disagreement and to seek answers regarding NALBOH accountability and activities, yet NJLBHA has been consistently rebuffed in its attempts; and

Whereas, the NALBOH Board of Directors has taken it upon itself to direct inappropriate, inaccurate and self-serving propaganda casting aspersions on NJLBHA and its officers; and

Whereas, NJLBHA has frequently asked that the NALBOH Board of Directors undertake to reform itself, particularly in regard to accountability, due process and expansion of member participation and rights, all of which we believe serve the betterment of public health; however, NALBOH Board of Directors has consistently refused to adopt any of the requested reforms.

Whereas, NJLBHA has requested that the New Jersey Congressional Delegation investigate the actions and activities of NALBOH, particularly in regard to due process issues and the use of federal grant funds; and

Whereas, Counsel for NJLBHA recommends that NJLBHA sever ties with NALBOH in order to maintain the integrity of NJLBHA and disassociate NJLBHA from NALBOH;

Therefore, NJLBHA withdraws its membership as a State Association from NALBOH, effective August 28, 2010, and urges all local Boards of Health in the State of New Jersey to do the same.
