# Approval of Meeting Minutes - Tabled

## Announcements

President Harris announced that the League of Municipalities Conference will be live November 16–18, 2021. She is waiting for information on how the conference will be conducted. NJACCHO Legislation Cocktail Reception on November 17, invitation was sent to all members; there will be a nominal fee of \$35.00.

President Harris previously sent members an article from the Kaiser Group in California regarding authority being removed from the health departments and being taken over by state legislators and executives.

President Harris reported that she received health alerts from Mr. Roman, CDC and the NJ Dept. of Health on the various diseases in Afghanistan and that part of the world. We are anticipating an increase in health issues resulting from entry along the southern boarders; Health Officers need to be on alert.

Mr. Saccenti discussed the potential resource table at the League of Municipalities' Conference; he explained how the exhibit table was set up in the past. We need to let the League know we are interested in hosting a table. Mr. Saccenti will complete the application.

## Sustainable Jersey – Steve Papenberg

## Marijuana Use Regulations

President Harris brought up the discussion on marijuana use and regulations in NJ. Beth Korn provided an update on what her town is doing. If a town has not made the decision by deadline, that town cannot participate for another five years.
